### TERMS AND CONDITIONS GOVERNING THE "VI GUARANTEE OFFER"

### INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO VODAFONE IDEA LIMITED (HEREINAFTER "VODAFONE IDEA/VIL") PRE-PAID ELIGIBLE SUBSCRIBERS PURCHASING THE ELIGIBLE PACKS AND USING ELIGIBLE SMARTPHONE DURING THE OFFER PERIOD AS MENTIONED HEREIN AND THE EXISTING SUBSCRIBERS UNDER EXTENSION OFFER [HEREINAFTER KNOWN AS "VI GUARANTEE OFFER"/ "OFFER"]. PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS OFFER. # A. <u>Vi Guarantee Program for 4G & 5G Handset Customers and Extension offer for Existing Subscribers:</u>

### 1. DEFINITIONS

- i. "Subscriber/s" shall mean the rightful user of the VIL mobile connection who is on a prepaid subscription, in whose name the mobile phone number (MSISDN) is registered with VIL.
- ii. "Active Subscriber/s" shall mean a Subscriber who uses the Subscriber Identity Module ("SIM") of VIL on a regular basis for purposes other than to participate in any Offer or contest offered by VIL.
- iii. "Eligible Pack(s)" shall mean unlimited calling with daily data recharge packs of Rs.299 and above purchased by the Eligible Subscriber during the Benefit Validity Period. ## 2. OFFER BENEFIT DETAILS FOR ELIGIBLE SUBSCRIBERS AND EXISTING SUBSCRIBERS

- i. Offer Eligible Subscribers fulfilling the eligibility criteria will be entitled to get a total of 130 GB extra data over a one-year period ("Benefit Validity Period") on a complimentary basis. Once the Offer is claimed, extra data will be credited to customer's account in 13 tranches of 10GB each valid for 28 days.
- ii. Extension Offer The Existing Subscribers fulfilling the eligibility criteria will be entitled to get a total of 130 GB extra data over a one-year period ("Benefit Validity Period") on a complimentary basis. Extra data will be directly credited to customer's account in 13 tranches of 10GB each valid for 28 days.
- iii. Extra data of 130 GB can be used only on 4G/5G network.
- iv. Restrictions and Other Conditions -
  - To utilize the extra data credited every time in a tranche (i.e. 10 GB), the customer is required to be active on the 4G/5G VIL network with an Eligible Pack (in case of Eligible Subscribers) and Eligible Pack for Existing Subscribers (in case of Existing Subscriber) and handset.
  - If the data benefit is not consumed within the validity of 28 days, the unutilised data will be forfeited.

- From 13th Aug 2024 00:01 hrs, available in all VIL service areas including Karnataka, Andhra Pradesh, Madhya Pradesh, Assam, North East & Orissa,

The Offer ends on 30<sup>th</sup> June, 2025 00.00 Hrs unless revoked by VIL ("Offer Period").

#### B. General
